to ensure statutory duties continue to be met and Rochdale Borough's priority of reducing NEET continues to be maintained.

A Task and Finish group was established (from above partners) to review in detail how Rochdale Borough can continue to maintain our partnership approach to reducing NEET whilst recognising that statutory duties in Careers Education, Information, Advice and Guidance (CEIAG) have changing (from September 2012).

The Task and Finish group have helped to develop the new specification for a targeted service and have also ensured that schools recognise and deliver against their new statutory duties.

The assessment has been based on statutory changes detailed within the Education Act 2011 for Local Authorities and Schools in relation to CEIAG and analysis of local need and priorities which has informed the development of a new specification which will go out to tender from September 2012 to commence 1<sup>st</sup> April 2013.

## 7 a). What does the function currently do? b). Describe the needs which this service meets?

Rochdale Borough Council currently commission to delivery the provision of Careers, Information Advice and Guidance (CIAG) from 1<sup>st</sup> September 2012 until 31<sup>st</sup> March 2013 in the Borough of Rochdale.

As a result of the statutory duties of local authorities and secondary schools, the service delivery will focus on providing a targeted service for vulnerable young people only. Rochdale Borough Council, via consultation with partners has defined the vulnerable groups. This is where demand is highest across the borough and will include the following groups:

- Looked after Children (LAC)
- Care Leavers
- Learners with a Learning Disability or Difficulty (LDD)
- Young Offenders
- Teenage Parents
- NEET (Post 16)

The commissioned service will also ensure the tracking and monitoring of young people's participation is maintained, maintain a Connexions office (Rochdale) with provision/access in other townships (Middleton & Heywood) and ensure specialist personal advisors are deployed to work with and support the most vulnerable young people into education, employment and/or training (EET).

#### 8. What changes do you propose to make?

The proposal sets out new ways of working to deliver a targeted service across Rochdale Borough which will ensure we meet statutory duties and continue to work with our most vulnerable young people, adults and their families. The aim of a support and outreach service will identify and intervene early and offer ongoing appropriate specialist support and guidance, which will enable young people to make informed, realistic decisions for effective transition into Education, Employment and/or Training (EET).
