1. INTRODUCTION

1.1 Rochdale Council is in the process of preparing the Core Strategy Development Plan Document (DPD) as part of its Local Development Framework. We have used the consultation results from the Issues and Options public consultation in developing the next stage of the Core Strategy, the Preferred Options stage.

1.2 This consultation report is primarily about what we did at the 'Issues and Options stage' and evidence of how we satisfied the regulations and our Statement of Community Involvement (SCI). Its purpose is to provide a record of all the consultation undertaken under Regulation 25 (Issues and Options) in the preparation of the Rochdale Core Strategy Development Plan Document.

1.3 Further along the process, when the Core Strategy Development Plan Document is submitted to the Secretary of State; this consultation statement will be updated and will report on the results from the Preferred Options stage. This will then feed into the requirements of Regulation 28 (Pre-submission consultation statement).

1.4 There are four clear stages in the preparation of the Core Strategy and the table below sets out these stages (where the shaded row is the stage we are at now).

3. ISSUES AND OPTIONS CONSULTATION

Issues and Options Consultation Reponses

3.1 We published a Core Strategy Development Plan Document - Issues and Options document and accompanying Sustainability Appraisal last year and consulted with the public for a period of six weeks. This formal period was from 8^{th} September 2008 – 3 November 2008. This helped identify what the key issues were, the extend of

background documents and strategies that required consideration in preparing this key document.

We did of course take into account any comments we received both before and after the given consultation period.

3.2 The table below sets out the schedule of consultation methods during the **Issues** and **Options** Stage.

4. Responses on Issues and Options

4.1 We had 536 responses to our issues and options document. A summary of the methods of response is below:

4.2 At the close of the consultation, 300 members of the public attended the public events and over 150 organisations made representations.

4.3 We have provided a summary of the main issues raised by respondents to each of the questions asked in the public consultation. 5. PREFERRED OPTIONS CONSULTATION

5.1 The current stage in the process for the Council is producing the Preferred Options document of the Core Strategy.

5.2 The public consultation process on the Preferred Options Document will commence from the **26th October until 7th December 2009** for a period of six weeks. However, the Council will continue to consult until the submission stage.

Principal methods of consultation

5.3 The table below outlines the methods of consultation that we will be using for the Preferred Options stage of the Core Strategy. It also identifies the aims of the methodology. The Council has already undertaken some consultation with key stakeholders and officers (shaded in grey).

Appendix 2 Press Release at Issues and Options stage

Have your say on plans for borough's future

Local people are being invited to have their say about the future development of the borough.

Rochdale Borough Council is putting together a new plan detailing what development should take place up to the year 2026. The plan, called the Core Strategy, once agreed, will form an important part of the council's Local Development Framework to guide the future allocation of land for housing, employment and recreation. The document will also set out which parts of the district should be protected against development.

Six possible options are being put forward in an 'Issues and Options' report and the council wants residents to get involved and help decide which the best option is. The options identify broad areas for development but don't allocate specific sites.

Councillor Alan Taylor, leader of Rochdale Borough Council, said: "This consultation is of major importance to the future of the borough and I urge local residents and businesses owners to get involved and have their say. You can really make a difference to helping shape the borough by making your voice heard and telling us what you think of the proposals."

Councillor Taylor added: "We will take people's views seriously and use the comments and suggestions in putting together the final strategy."
