1. **INTRODUCTION**

- 1.1 Rochdale Council has prepared a draft Statement of Community Involvement (SCI) which sets out how Rochdale Council will undertake to actively involve and engage the local community in the preparation of the SCI.
- 1.2 The Statement Community Involvement is a document that sets out the consultation activity that we will carry out at various times in the production of the Local Plan and guidance documents, and in the determination of planning applications. It explains how people can get involved and have their say.
- 1.3 The current SCI was adopted in October 2010. We are now proposing an update to this document because over recent years there have been changes to the planning system and related legislation. Preparing the new SCI will enable the changes to the incorporated within the document. It has also provided an opportunity to review our consultation and engagement techniques, particularly the development of social media.
- 1.4 It is important, in developing the final version of the SCI, to have the view of local businesses, key stakeholders and other interested parties.

2. CONSULTATION

- 2.1 The Council intends to carrying out a public consultation and seek views on the content of the SCI consultation draft over a six week period between Monday 20 July 2015 Monday 31 August 2015.
- 2.2 The consultation will comprise of the following methods:

 - Notification emails to local Councils adjacent to Rochdale;
 - The consultation will be publicised on the Councils' websites: www.rochdale.gov.uk/consultations
 - Copies of the draft SCI are available to view at each of the Borough's local libraries (see list of libraries in Appendix 1).
